





QUAM REPORT ON INCREASED KNOWLEDGE, AWARENESS AND ASSESSMENT IN KARAMOJA, WEST NILE AND ACHOLI HUMANITARIAN PARTNERS FROM $9^{\rm TH}$ TO $21^{\rm ST}$ NOVEMBER 2020 WITH SUPPORT FROM OXFAM.

1. Introduction

The QuAM is a self-assessment initiative developed by NGOs and for NGOs. It aims to enhance the credibility and effectiveness of NGOs and contribute to the overall improvement in the public legitimacy of the NGO sector. With support from OXFAM, QuAM conducted a one day QuAM sensitization meetings and two day Quam assessment of NGOs in Karamoja, West Nile and Acholi sub-regions aimed at creating awareness on QuAM and buy-in in the reformed QuAM and elect West Nile regional QuAM committee and regional QuAM host organizations'. Uganda National NGO Forum (UNNGOF) therefore invited the Executive Directors or Coordinators of organizations for a one-day sensitization meeting which took place in the districts of Moroto, Arua and Gulu respectively.

In preparation for participants to attend the sensitization meeting, participants were requested to do the following;

- Propose the regional QuAM host organization (QuAM regional host organization terms
 of reference were attached to guide participants) and propose names for the regional
 QuAM committee members i.e. The Chairperson, Secretary, Treasurer, 2 committee
 members (QuAM regional committee terms of reference were attached to guide
 participants) (For West Nile sub-region where QuAM did not have this structures in
 place)
- Fill in the QuAM application form (the application form was attached to the invitation)
- Fill in the QuAM assessment tool (the tool was attached to the invitation)

For West Nile sub-region, after the participants proposed the names, the names were presented to the regional NGOs during the sensitization meeting for election.

QuAM sensitization was conducted by the National QuAM Coordinator in all the three regions and QuAM assessment of NGOs in Karamoja, West Nile and Acholi regions was conducted by the independent Regional QuAM Committee members of those specific regions with support from the QuAM secretariat and UNNGOF.

During the QuAM assessment of the 32 (Thirty-two) NGOs in Karamoja, West Nile and Acholi regions, most of the candidate NGOs had prepared for the exercise and has most of the required items during the QuAM verification as clearly shown in the assessment tool and most of them still had major gaps as stated in the improvement plan samples attached in appendix B in this report.
